Please disregard the previous emails requesting signature.** I was notified by our banker early this morning that requirements changed after last night.

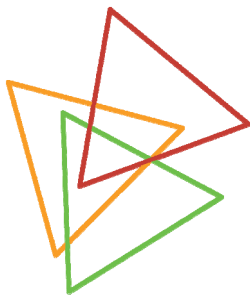
I just submitted Kinesics' application to this program with our bank, and I will keep you updated on the progress moving forward.

In case you are curious, here is my summary of this particular program:

The Paycheck Protection Program is a loan guaranteed 100% by the Federal Government. It was recently passed by Congress as a way to help small businesses keep their employees on payroll and avoid unnecessary layoffs due to COVID-19. The loaned money will be 100% forgiven by the government if we use the funds solely for the purposes of paying our employees and utilities. Unless otherwise advised by our legal and financial teams, we will only be using funds for those purposes.

I pray these funds come quickly so that we can continue to pay our people. I am thankful we have this available to us so that we can support our staff whose livelihoods depend on their paycheck from Kinesics.

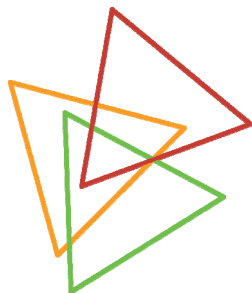
You will be receiving another email from me using **Adobe Sign** that will allow you to **sign the necessary documentation online**.
